रेल्वेचे विलंबाने येणे ३० टक्क्यांनी कमी

प्रतिनिधी, नागपूर

रेल्वे म्हणजे विलंबानेच येणार, असा सर्वसाधारण समज आणि रेल्वेच्या विलंबाने ते सिद्धही केले आहे, पण रेल्वेखातेही आता कात टाकायला लागले आहे आणि विलंबाचा शिक्का मिटवण्यात ते बऱ्याच अंशी यशस्वीही ठरले आहेत. भारतातील २५०० पेक्षा अधिक महत्त्वाच्या रेल्वेस्थानकांवर गेल्या सहा महिन्यात केलेल्या सर्वांगण विश्लेषणावर रेलयात्री डॉट इनने काढलेल्या निष्कर्षानुसार राष्ट्रीय स्तरावर रेल्वे विलंबाने येण्याची सरासरी २०१६ या वर्षाच्या सुरुवातीपासून ३० टक्क्यांनी कमी झाली आहे. एवढेच नव्हे, तर जून २०१६ च्या शेवटी सरासरी राष्ट्रीय रेल्वे विलंबाने येण्याचा इंडेक्स आजही ३५.०३ मिनिटे इतका अधिक राहिला आहे.

या अभ्यासातून दर महिन्याला देशभरात विविध स्थानकांवरून रेल्वेने प्रवास करणाऱ्या एक दशलक्षपेक्षा अधिक रेल्वेच्या घावण्याची परिस्थिती विचाराधीन घेण्यात आली. रेल्वे प्रवाशांची रेल्वे विलंबाने येण्याच्या इंडेक्सची व्याख्या प्रवाशांना एका रेल्वे स्थानकावर त्या रेल्वेच्या निश्चित आगमनाच्या वेळेच्या पलीकडे किती वेळ थांबावे लागले, यावर आधारित आहे. जगभरातील या इंडेक्स ऑपरेटिंगची व्याख्या ज्यात भारतीय रेल्वेचाही समावेश आहे. त्यातून केवळ त्याच्या अंतिम निर्धारित ठिकाणी झालेल्या विलंबाचा विचार केला जातो. याचाच अर्थ, एखादी रेल्वे त्याच्या निर्धारित ठिकाणी वेळेत पोहोचली आणि इतर महत्त्वाचे सर्व ठिकाणी तिला विलंब झालेला असला तरीही संपूर्ण प्रवास हा ऑनटाईम असल्याचे मानले जाते. यातूनच रेल्वेला जादा बफर कालावधी एकतर त्यांच्या शेवटच्या स्थानकापूर्वी किंवा त्यांच्याजवळ का दिला जातो, याचे स्पष्टीकरण मिळते, जे त्यांचा ऑनटाईम रन पूर्ण करण्यासाठी असते. तथापि, रेलयात्री डॉट इनच्या अभ्यासातून महत्त्वाचे सर्व स्थानकांवर जेथे प्रवासी रेल्वेत बसतात त्या विलंबाचा विचार करण्यात आला आहे.
