Advocate Nitin Gaware-Patil,
appearing for the accused, said
that even if the offences against
him were serious, the court should
exercise its discretion in view of
the girl's affidavit, which ex-
pressed her desire to live a peace-
ful life and focus on her academic
career. However, Chief Public
Prosecutor Anura S Pai, represent-
ing the state, said that even if par-
ties had reached an agreement
and were seeking quashing of FIR
by consent, given the offences
against the minor are serious and
severe, the petition should be dis-
missed.

The girl's affidavit indicated
that due to intervention of close
friends and others, they had set-
tled the conflict. "On account of
pending criminal prosecution, al-
ready damage has been caused to
the reputation and educational ca-
reer of the deponent," it stated.
