## 27.45 lakh homes to get drinking water tap connections in state this year

PUNE, MAY 3

MAHARASHTRA AIMS to provide 27.45 lakh drinking water tap connections to 13 districts, 131 blocks and over 12,000 villages during 2021-2022. This was proposed in its annual plan under Jal Jeevan Mission (JJM) to the central government at a virtual meeting last month. There are 1.42 crore rural households in the state, out of which 91 lakh have access to piped drinking water.

For the ongoing financial year, the state is expected to receive cen-

tral government funding worth Rs 3,000 crore towards the implementation of this programme.

Last year, the state government provided 37.15 lakh connections. As of May 3, a total of 8,629 villages have benefited from the tap water connections since the mission was launched in 2019. Wardha, Dhule, Kolhapur and Satara remain ahead in the total number of tap connections under this mission.

According to the current year's plan, the state plans to impart training to 42,000 personnel at state and district levels, who are engaged in water and sanitation missions, and engineering cadre

along with programme management unit staff this year. Skill training will be offered to an additional 72,000 trades, including masons, plumbers, fitter, motor mechanics, pump operators, whose supplementary services will be required in building these water supply services. The state has also adopted to undertake district field water testing labs.

Since the launch of the 'Har ghar jal' programme of JJM, Jalgaon district along with 20 blocks and 7,737 villages have obtained 100 per cent coverage of drinking water through taps in households.

## Deshmukh moves Bombay High Court against CBI FIR

**Mumbai:** Former Maharashtra Home Minister Anil Deshmukh on Monday approached the Bombay High Court with a writ petition against the FIR filed by the CBI against him and unknown persons on charges of bribery, corruption and criminal conspiracy.

The CBI last month registered the FIR under the Prevention of

Corruption Act and IPC, stating that the preliminary enquiry (PE) prima facie revealed that a cognizable case is made out in the matter wherein Deshmukh and unknown others attempted to obtain "undue advantage for improper and dishonest performance of his public duty". Besides a main prayer to quash

and set aside the FIR, pending hearing, Deshmukh has also sought interim protection from coercive steps. The HC is likely to hear the plea this week.

The CBI had initiated a probe

against Deshmukh after the Bombay HC directed it to carry out a preliminary enquiry into corruption allegations of former Mumbai Police Commissioner Param Bir Singh against then Maharashtra

Home Minister Anil Deshmukh.

Terming the case "unprecedented", the court on April 5 had asked the CBI to complete the preliminary probe as early as possible, preferably within 15 days. **ENS**

## Patil comment on Bhujbal sparks political row

**Mumbai:** BJP president Chandrakant Patil triggered a war of words and many questions on Monday when he asked NCP minister Chhagan Bhujbal to weigh his words while speaking about the BJP. Patil said that Bhujbal should remember that he was only "out on bail" and that he may have to pay a heavy price. "Bhujbal should comment on Pandharpur (by-election results). Why should he speak about Bengal... You are out on bail, you have not been acquitted yet. You should be careful about what you say, or else you will have to pay a heavy price...", Patil said while speaking to a Marathi television channel.

Patil was reacting to a comment by Bhujbal on the West Bengal elections. "If elections were held in the present circumstances, then the BJP would have been completely wiped out in the country. People have turned their backs on the BJP. There is a wave against the BJP," senior NCP leader and Food and Civil Supplies Minister Chhagan Bhujbal had told a Marathi news channel while reacting to the West Bengal poll results. Bhujbal on Monday questioned Patil's statement and asked whether the BJP leader was indicating that he could influence the judiciary. **ENS**
