Cops raid 'call centre' in Delhi, arrest three for duping woman

EXPRESS NEWS SERVICE PUNE, AUGUST 5

THE CYBER Crime Cell of the Pune City Police raided a call centre in Delhi and has arrested three persons for allegedly duping a woman from Nigdi area.

Police said the woman had placed a request for loan on "Sulekha" website a few days

The accused have been iden-Shamkumar tified as Premkumar Jha (26), a resident of Mukundpuri, Usha, alias Khushi Gupta, alias Khushi Agarwal (26), of Azadpuri, and Deepchandra Sharman Singh (27) of Ferozabad – all residents of Delhi.

Police said the suspects, who claimed to be staffers of "Vijay Fiance", got the contact details of the complainant from a website where she had placed a request for a loan of Rs 1 lakh.

According to the complaint, the accused had asked the woman to pay Rs 2,500 as registration charges for a bank account. Later, they called her, claiming that the company has approved her loan of Rs 1.6 lakh and she will have to deposit an additional Rs 61,450 as processing fees, added the complaint. But, for that, the accused had given the woman a different bank account number. She deposited the amount but never got the loan amount, said an official.

She registered an FIR at the Nigdi police station, following which the accused were charged under sections 419, 420 of the Indian Penal Code and sections of the Information Technology Act.

During investigation, a team led by Senior Inspector Radhika Phadke and Inspector Deepak Lagad nabbed Deepchandra Singh in Delhi. During questioning, he disclosed the details of the other two suspects -Shamkumar and Usha, alias Khushi. The two were running a call centre in Shiv Market, Pitampura area of Delhi, said police.

Pune police raided the spot and arrested the duo. As many as seven cell phones, nine SIM cards, eight ATM cards, three

with other items. The accuse, were brought to the city after being granted a transit reman by a court in New Delhi o Thursday.

'Shamkumar is a graduat who had previously worked un der a Chartered Accountant. H happened to meet Khushi, alia Usha, who earlier worked with a finance company. N Deputy Commissioner of Police (Cyber Crime) Sudhir Hirema 200 during a press conference of Saturday.

"Together, the duo floated a fake finance firm. They com tacted people who placed re-7 quests for seeking loan on web-7 sites. They asked the loan? seekers to deposit money in Deepchandra's bank accounts as processing fees and othercharges, but never dispatched any loan amount. So far, we have confirmed they have of cheated three persons including a woman in Nigdi. Further investigation is on," he added.
